Sub: Scrutinizer's Report for passing of resolution through Postal Ballot (remote e-voting).

### 1. Appointment as Scrutinizer

The Board of Directors of Suyog Telematics Limited ("the Company") appointed the undersigned as Scrutinizer to ensure that the process of Postal Ballot as prescribed under Section 108 and 110 of the Companies Act, 2013 ('the Act') read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014 ('the Rules') as amended from time to time and Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('the Regulations'), is conducted in a fair and transparent manner, for passing of the resolutions as mentioned in the Notice of Postal Ballot dated February 06, 2024 ("Notice") issued by the Company in accordance with General Circular No. 14/2020 dated April 8, 2020, No. 17/2020 dated April 13, 2020 and the latest one being General Circular No. 09/2023 dated September 25, 2023 issued by the Ministry of Corporate Affairs ('MCA Circulars').

- 2. The Postal Ballot conducted through remote e-voting in terms of MCA Circulars, has been completed and now I submit my report as under:
- 2.1. The management of the Company is responsible to ensure compliance with the requirements of the Act and Rules made thereunder including the above-mentioned MCA Circulars and the Regulations. Our responsibility as Scrutinizer is restricted to make Scrutinizer's Report of the votes cast 'in favor' and 'against' the resolution(s) stated in the Notice based on the reports generated from the e-voting system provided by National Securities Depository Limited ("NSDL"), the authorized agency engaged by the Company for providing e-voting facilities.
- 2.2. The Company had availed the e-voting platform/facility offered by NSDL for conducting Postal Ballot process through remote e-voting.
- 2.3. The Company on Friday, February 09, 2024, completed the dispatch of the Notice only through electronic mode to those members whose e-mail addresses were registered with the Company/Depositories as on the cut-off date being Friday, February 2, 2024. The Company had also circulated corrigendum to the Notice of Postal Ballot on February 10, 2024 through electronic mode to the members. In compliance with the requirements of the MCA Circulars, the hard copy of Postal Ballot Notice along with Postal Ballot Forms and pre-paid business envelope were not sent to the shareholders for this Postal Ballot and shareholders were requested to communicate their assent or dissent through the remote e-voting system only.

- 2.4. The remote e-voting period commenced on Sunday, February 11, 2024 at 9:00 a.m. (IST) and ended on Monday, March 11, 2024 at 5:00 p.m. (IST).
- 2.5. Votes cast through remote e-voting till 5.00 p.m. on Monday, March 11, 2024, being the last date and time fixed by the Company for voting are considered for my scrutiny.
- 2.6.
